Explanatory Note

This Amendment No. 6 (this "Amendment No. 6") amends and supplements the Schedule 13D (the "Original Schedule 13D") filed with the Securities and Exchange Commission (the "SEC") on September 10, 2018, as amended by Amendment No. 1 filed with the SEC on October 12, 2022 ("Amendment No. 1"), Amendment No. 2 filed with the SEC on October 21, 2022 ("Amendment No. 2"), Amendment No. 3 filed with the SEC on October 31, 2022 ("Amendment No. 3"), Amendment No. 4 filed with the SEC on January 5, 2023 ("Amendment No. 4") and Amendment No. 5 filed with the SEC on January 17, 2022 ("Amendment No. 5" and, together with the Original Schedule 13D, Amendment No. 1, Amendment No. 2, Amendment No. 3 and Amendment No. 4, the "Schedule 13D"), relating to the trust units representing beneficial interests (the "Trust Units") in Enduro Royalty Trust (n/k/a Permianville Royalty Trust), a Delaware statutory trust (the "Issuer"). The address of the principal executive office of the Issuer is 601 Travis Street, 16th Floor, Houston, Texas 77002. Except as otherwise specified in this Amendment No. 6, all items left blank remain unchanged in all material respects. Capitalized terms used herein but not defined herein have the respective meanings ascribed to them in the Schedule 13D.

Responses to each item of this Amendment No. 6 are incorporated by reference into the response to each other item, as applicable.

Item 5. Interest in Securities of the Issuer

Item 5 of the Schedule 13D is hereby amended and supplemented as follows:

(a), (b) Holdings is the sole record and beneficial owner of 7,795,920 Trust Units, which represents 23.6% of the outstanding Trust Units (based on 33,000,000 total outstanding Trust Units as of November 14, 2022, as provided in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2022, filed with the SEC on November 14, 2022).
