The distribution primarily represents oil production during the month of October 2011 and natural gas production during September 2011, and includes the proceeds from the settlement of applicable hedge contracts.

Capital expenditures included in the net profits calculation during the period were approximately \$1.8 million.

Enduro Royalty Trust is a Delaware statutory trust formed by Enduro Resource Partners to own a net profits interest representing the right to receive 80% of the net profits from the sale of oil and natural gas production from certain of Enduro Resource Partners' properties in the states of Texas, Louisiana and New Mexico. As described in the Trust's filings with the Securities and Exchange Commission, the amount of the periodic distributions is expected to fluctuate, depending on the proceeds received by the Trust as a result of actual production volumes, oil and gas prices and the amount and timing of the Trust's administrative expenses, among other factors.
