Permianville Royalty Trust Announces Monthly Cash Distribution

HOUSTON, Texas—(BUSINESS WIRE)—May 15, 2020

Permianville Royalty Trust (NYSE: PVL, the “Trust”) today announced a cash distribution to the holders of its units of beneficial interest of \$0.015300 per unit, payable on June 15, 2020 to unitholders of record on May 29, 2020. The net profits interest calculation represents reported oil production for the month of February 2020 and reported natural gas production during January 2020. The calculation includes accrued costs incurred in March 2020.

The following table displays reported underlying oil and natural gas sales volumes and average received wellhead prices attributable to the current and prior month recorded net profits interest calculations.

Recorded oil cash receipts from the oil and gas properties underlying the Trust (the “Underlying Properties”) totaled \$2.5 million for the current month on realized wellhead prices of \$49.62/Bbl, down \$0.6 million from the prior month distribution period, which primarily is due to lower realized prices.

Recorded natural gas cash receipts from the Underlying Properties totaled \$0.6 million for the current month on realized wellhead prices of \$1.70/Mcf. Natural gas volumes increased due to the first production from three new drilled wells in the Haynesville, which are operated by a large, public Haynesville-focused company, but the increased production was offset by lower realized prices.

Total accrued operating expenses for the period were \$2.2 million, a \$0.1 million increase month-over-month from February 2020. Capital expenditures remained constant at \$0.2 million from the prior month.

About Permianville Royalty Trust

Permianville Royalty Trust is a Delaware statutory trust formed to own a net profits interest representing the right to receive 80% of the net profits from the sale of oil and natural gas production from certain, predominantly non-operated, oil and gas properties in the states of Texas, Louisiana and New Mexico. As described in the Trust’s filings with the Securities and Exchange Commission (the “SEC”), the amount of the periodic distributions is expected to fluctuate, depending on the proceeds received by the Trust as a result of actual production volumes, oil and gas prices, the amount and timing of capital expenditures, and the Trust’s administrative expenses, among other factors. The amount of such cash received or expected to be received by the Trust (and its ability to pay distributions) has been and will continue to be directly affected by the volatility in commodity prices, which have declined sharply since the beginning of 2020 in response to the economic effects of the COVID-19 pandemic and the dispute over production levels between Russia and the members of the Organization of Petroleum Exporting Countries, including Saudi Arabia, resulting in an oversupply of crude oil and exacerbating the decline in crude oil prices, and could remain low for an extended period of time. Continued low oil and natural gas prices will reduce profits to which the Trust is entitled, which will reduce the amount of cash available for distribution to unitholders and in certain periods could result in no distributions to unitholders. Other important factors that could cause actual results to differ materially include expenses of the Trust, reserves for anticipated future expenses and the effect, impact, potential duration or other implications of the COVID-19 pandemic. In addition, future monthly capital expenditures may exceed the average levels experienced in 2019 and prior periods.
